Blended Learning Admissions Statement

Admission requirements include the application, and approval by PSP or Day School Administrator and prior school records. The school reserves the right to check with previous schools to investigate previous background. Students who have unpaid bills from a previous school may not be admitted.

1. Low academic performance as indicated by a standardized test and/or previous school records.
2. Serious health, emotional or behavioral problems.
3. Physical handicaps which would significantly impair the learning process.

Blended Learning Application Process

Rincon Valley Christian School offers a program for students who desire an education in a Christian environment and who are capable of achievement in a program that pursues academic excellence. The required admission process is:

- a) The student has completed one year in the full time day program.
- b) The parent(s) or the legal guardian and student signs the Student and Parent Contracts.
- c) Submission of a properly completed application for admission and the registration fee of \$250 per student is received.
- d) Approval for program by PSP or Day School Administration.
- e) Selected classes or course work are available and approved.
- f) Tuition payment plan is confirmed.
